Taoufik ABBAD, Head of Division, Ministry of Economy and Finance, MoroccoDr. Abbad joined the Department of Studies and Financial Forecasting in 2005. His areas of expertise include economic growth, competitiveness and macroeconomic forecasts. Holds a PhD in Economics from the University of Nice-Sophia Antipolis, Center for Studies in Macroeconomics and International Finance CEMAFI in 2004. He has directed several studies and published numerous works in the fields of macroeconomics.



Samir ABDELKRIM, Founder, StartupBRICS and EMERGING Valley, FranceBetween 2014 and 2018, Abdelkrim traveled Africa's innovation and analyzed the digital ecosystems of 25 African countries. A field experiment from which he pulled a book, Startup Lions, prefaced by Xavier Niel and Tidjane Deme. He is also a columnist on African tech in major national titles like Les Echos or Le Monde where he specializes in African startups. He is also the founder of StartupBRICS.



Roger ALBINYANA, Director, Mediterranean Regional Policies and Human Development department at the European Institute of the Mediterranean (IEMed)

Dr. Albinyana is associate professor of teaches international economic policy at the Faculty of Economics of the University of Barcelona. From 2013 to 2016, he served as secretary general for Foreign and EU Affairs of the Government of Catalonia. During that period, he was also a member of the EU Committee of the Regions. From 2010 to 2013 he served as advisor and expert on private sector development at the Secretariat of Union for the Mediterranean. He is also a board member at CIDOB, Barcelona Centre for International Affairs.



Patricia AUGIER, President of Scientific Committee & Coordinator of FEMISE and IM and Professor at Aix-Marseille University, France

Nathalie CRESTE, Adviser to the Director for Mobility of workers, Directorate General Employment and Social Affaires, European Commission
